During the three-day International Conference approximately 200 scientists from Greece and abroad presented their proposals on current and very urgent environmental issues. In addition to the 15 conference sessions, the HELECO was further enhanced with fourteen round-table discussions and special events that allowed the development of lively and fruitful exchanges between the participating scientists -many internationally acclaimed- and the approximately 1000 Conference attendees.

The shipbuilding and ship repair sector is an important one for the Greek industry, with its long experience and technical "know-how" and the significant number of people employed directly or indirectly by it.

For the last 10 years the sector has been in deep crisis, due to international circumstances, such as the opening of markets in neighbouring countries and the dynamic entry of countries of the Far East with low labour costs, its problems exacerbated by the lack of a national industrial strategy.

The Naval Architects and Naval Mechanical Engineers expressed their commitment and offered their support to every effort made for the revival and modernization of Shipbuilding in Greece on condition that such effort be part of a comprehensive strategic plan to lead the sector out of the crisis it entered in the eighties without being able to recover since, despite the measures of fragmented or emergency nature taken by the State at various times.

28-30 SEPTEMBER 2005 FEANI

On 28-30 September took place at the hotel DIVANI CARAVEL the annual meeting of FEANI (Fédération Européenne des Associations Nationaux d' Ingénieurs). One hundred engineers from 25 countries attended.

With the General Assembly of FEANI, Mr.Kostas Alexopoulos's three-year term in the office of the President came to its conclusion. This was Mr. Alexopoulos', a Mechanical-Electrical Engineer, second term as FEANI President and the first time in the Federation's history a president served for two consecutive terms. Mr.Alexopoulos was elected President for the first time in 1999 in Rethymnon, Greece and for the second time in 2002 in Larnaca, Cyprus.

The very successful presidency of Mr.Alexopoulos, during which FEANI gained back its prestige, was greeted by the participants who offered the parting president several commemorative gifts. Mr.Alexopoulos was also declared Honorary President of FEANI.

The general assembly elected Dr. Willi Fuchs as the new President. Mr.Fuchs had served as Director General of VDI and vice-president of FEANI in the years 2002-2005. Dott.

Alcide Gava, member of the Council of FEANI in the period 2001-2005, was elected Vice-President. Six new members of the executive council were also elected: Dr.J.Birch (UK), Mr.L.Olsen (DK), Prof. Marko Jagovic (SI), J. Molina (ES) and Mr. Ch.Sinanis (GR), Mechanical-Electrical Engineer. Mr. Sinanis' election is of special importance, as the seat was contested by candidates from other Mediterranean countries. All elected officers will serve three-year terms.

29 SEPTEMBER – 2 OCTOBER 2005

5th Congress on Metal Structures, Xanthi, EEME, Laboratory of Metal Structures, Faculty of Engineering, Democritus University of Thrace, TEE, TEE/Thrace

The Eurocodes-with their supporting documentation-now nearing completion and the successful construction effort related to the Olympic Games 2004 boosted the confidence in steel as a structural material, which in turn promises a bright future for steel in construction.

3rd Hellenic Conference on Road Safety Co-organized by the University of Patras, SES, TEE under the aegis of the Ministry for the Environment and the Ministry of Transport and Communications

A program of initiatives in dozens of dangerous places-traps of the national highway system and the regional road system will go into effect by the Ministry for the Environment, Physical Planning and Public Works after a proposal made by the TEE-Observatory of Road Safety . This was announced by the Undersecretary for the Environment Mr. Xanthopoulos in his Press Conference given during the 3rd Hellenic Conference on Road Safety.

The 2nd event for extroversion; information session for the Diplomatic Corps

Greek Engineering Firms, suffocating in the limited internal market, need to cross the borders with the urgently needed support of the State, was emphasized during the one-day event. This time, both parties agreed, the problems that plagued earlier efforts resulting to the collapse of large construction companies should be avoided. The representatives of TEE also acknowledged the excellent relationship between the two bodies and stressed that this unprecedented cooperation will continue and further improve in 2006.

14-15 OCTOBER 2005 TWO-DAY WORKSHOP "Liquid Waste Management with decentralized Treatment Systems"

The Central Union of Municipalities and Communities of Greece, TEE, the Union of Community Water and Waste Management Companies and the Municipality of Karditsa coorganized a two-day workshop, at Plastira Lake.

- During the event the following issues were addressed:
 - The importance and development of a decentralized urban waste management system.
 - The fundamental technologies of a decentralized liquid waste management system, such as: alternative systems collection and disposal, modern of technologies of septic tanks, rotating bio-disks, cyclical processes of active mud, different types of filters, (intermittent sand-filters and bio-filters with manmade filler materials), treatment systems based on aquatic plants (floating aquatic and man-made wetlands), systems based on soil and deeper geological formations (slow application, surface flow and fast filtration), stabilization ponds, systems of aquatic cultures, membrane technologies.
 - Main problems of decentralized urban liquid waste management.

13-15 OCTOBER 2005 5th Conference "Hellenic Language and Terminology" Nicosia, Cyprus

The aim of the Conference was both to present the current situation of the Hellenic Language and Terminology as it is formed within the multilingual environment of the European Union as well as in relation with the requirements of the developing Information Society, and to coordinate the terminological work in Greece and Cyprus.

The thematic structure of the Conference was:

- 1. Diachronic aspects of Terminology
- 2. Linguistic-Ontological principles of Terminology
- (Terminology and knowledge, designating principles and methods, etc.)

- 9. Activities of organizations and bodies for Terminology.





17-21 OCTOBER 2005 2nd International Congress and Exhibition: "Ancient Greek Technology" Athens, Co-organizers: TEE, EMAET, KDEMT

The aims of the Conference were:

a) To inform and educate the public on the Ancient Greek Civilization and especially its technological aspect, which despite its tremendous importance is not widely known and is not taught in schools.

b) To underline the importance of technology to every civilization and to boost the modern Greeks' interest in technology.

The proceedings of the Conference were recently published by TEE in one volume and were presented to the public on 2.11.2006.

19 OCTOBER 2005 INVITATION "Greek Platform for Research and Technology in Construction with emphasis in Sustainable Construction and the Protection of our Cultural Heritage"

With this seminar the TEE asserted its role as the National Coordinator for the Greek Platform, to be recognized by the Ministry of Development, and included this event-on the occasion of the formation of the 7th FP for R&D-in a set of initiatives undertaken for the enhancement of the Program and the integration of strategic development objectives in it. It should be noted that the contribution of the Greek Engineers in the R&D of the country is important; as a recent TEE survey indicate 8,500 engineers out of the 100,000 TEE-TCG members (an approximate 10%) are involved with R&D.

10 NOVEMBER 2005 ONE-DAY SEMINAR

The Role of State Labs in Material and Construction Works Quality Improvement

The Technical Chamber of Greece organized a one-day event, on Thursday 10 November 2005 in EBEA.

The purpose of the seminar was to analyze the work and problems faced by the State Laboratories of Public Works as well as the redefinition of their role in the new realities and modern demands. Specifically, the seminar aimed at emphasizing the importance of creating a network linking the State Laboratories of Public Works, central and regional, as well as the establishment of relevant regulations required to enable:

1. The effective quality control of Construction Works (public and private) in cooperation with the supervising authorities.

2. Quality control and conformity of structural materials and market monitoring regarding the implementation of Directive 89/106/EEC, use of the appropriate European Standard, as well as the designation CE for structural materials, which although mandatory for the country has not been implemented to this day.

The thematic structure of the Seminar was:

- 1. State Labs of Public Works: Past, Present and Future.
- 2. Public Works Quality Control.
- 3. Structural Materials (Directive 89/106/EEC): Greek and European Legislation.
- 4. The role of State Labs-Accreditation-Market Monitoring.

15 NOVEMBER 2005 Regulations for Internal Electric Installations (KEHE)-ELOT HD Standard 384, Athens

It is the government's decision to implement a new code for electric installations, according to ELOT HD Standard 384, going into effect on 1 March 2006, in replacement of the Regulation for Internal Electric Power Installations. The technical studies, installation, modifications, retro-fittings and checks will be made according to the new code.

20 NOVEMBER 2005 One Step Away from Digital Strategy, Round Table Discussion, Athens An Event organized by TEE-TCG and the Hellenic Association of Computer and IT Engineers in the context of the "dte/COMDEX 2005", 18-20.11.2005

The Technical Chamber of Greece participated in the Digital Fair "dte/COMDEX 2005", organized on 18-20 November 2005 at the exhibition center EXPO-Athens.

TEE shared a booth with the Hellenic Association of Computer and IT Engineers and exhibited its Data Bank, Digital Library as well as other activities in Digital Technologies. Visitors showed great interest in the TEE booth.
